Misty Brook Farm Summer Camp is an addition to our year-round riding program.

All levels of riders are invited to join the fun, from beginner to advanced.

Students will learn horse care, barn management, and will ride one of Misty Brook Farm's horses on a regular basis.

Karla Frank, the owner and head instructor was trained in Germany, England and the US. She is certified by the American Riding Instructors' Association.

Spring Horse Day Camp is from Monday through Tuesday, 9.30AM through 5 PM, April 13<sup>th</sup> and 14<sup>th</sup>, 2009.

Summer Horse Day Camp is from Monday through Friday, 9.30AM through 5 PM, June 29th through July 3<sup>rd</sup>, 2009.

Participants must wear an approved helmet when mounted and have suitable footwear (shoes with a distinct heel, no sneakers) while riding. Comfortable pants should be worn, no shorts while riding please.

### REFUND AND CANCELLATION POLICY

Cancellations and refunds allowable up to 10 calendar days before start of camp.

Tuition is \$360 per week for the Summer Camp and \$160 for the Spring Camp. A \$100 non-refundable deposit is required and will be credited to the

tuition cost. The full tuition amount is due 5 calendar days before the start of camp.

No refunds will be given if participants leave during the session, unless a written verification of injury or physical illness issued by a licensed physician is presented.

Water is provided, but participants must bring their own lunches and snacks, and other beverages if desired.
